## **Consultation on Ashlawn School Non-Selective Admissions Policy 2022-23**

We recently launched a consultation regarding the proposed policy for Ashlawn School Non-Selective Admissions 2022-23.

The consultation document was sent to a wide range of stakeholders to ensure that feedback would be representative of the community our school serves and operates within. The consultation has now come to an end. This document summarises the feedback we have received from consulted parties, outlines Ashlawn School's response to this feedback, and sets out the actions that will be taken as a result of the consultation period.

We received 16 responses to the consultation.
